## **Extracts from the OCA Constitution**

(re : Executive Committee)

5.3.4 Subject to these Rules and Regulations in general and rule 5.3.1 in particular, a member shall be entitled or subjected to all rights, privileges and obligations explicitly, or implicitly attached to the membership of the association, including the right to seek office and the right to vote at the General body; and such obligations shall include regular attendance, prompt payment of dues, participation in Association activities and upholding of the traditions, values and principles of the school and the association.

6.1.1. Composition, Election and terms of Office

The Committee shall consist of fourteen members, including the Office Bearers.

- 6.1.2. (i) The General Body shall elect from amongst its members the following Office Bearers for terms not exceeding two years at a time :
  - One President
  - One Secretary
  - One Treasurer
- (ii) The members to be elected as the President, the Secretary and the Treasurer shall be persons not less than 30 years of age.
- (iii) In addition, the General Body shall elect nine members for a period of two years to the Executive Committee.

#### 6.1.3 Election Procedure

The following procedure will be observed for election to the Executive committee: (i) A six week notice (prior to General Body Meeting) will be mailed by the Secretary to all members informing them regarding election to the Executive Committee and inviting nominations for the same.

- (ii) Nominations will be filed with the Principal, St. Columba's School (who will be the authority for the conduct of the election) not later than four weeks before the date of the General Body meeting. The Principal will forward all nominations to the Secretary.
- (iii) The Secretary will mail to the member's details of the nominations received along with brief particulars of the candidates at least two weeks prior to the General Body Meeting.
- (iv) The venue of the election shall be the school.
